**Applications are due by MARCH 14th 2008 (FRIDAY midnight). A non-refundable entry fee of \$50.00 is due with the return of the photographic release and contestant questionnaire.**

**RULES**

- 1) Contestant must be at least 21 years of age.
- 2) Contestant must be a resident of Northeast Oklahoma.
- 3) Contestant must check in with the contest manager one hour prior to the contest beginning (9:00pm).

**REQUIREMENTS**

- 1) Winner must be present at as many community functions as possible.
- 2) Winner must represent "leather" in a positive manner throughout the community.
- 3) Winner must promote unity, camaraderie, brother/sisterhood throughout the community.
- 4) Winner must actively participate in at least 3 benefits during the next 12 months.

**\*If the above requirements are not met, the winner will be asked to relinquish his title to the first runner-up.**

**Tulsa Mr. Leather 2008 will receive: \$50.00 prize monies, the title belt "TULSA MR. LEATHER 2008", and entry fee to the Oklahoma Mr. Leather contest in October.**

## JUDGING CRITERIA

Contestants will be judged in at least four (4) categories for a total of 0 to 100 points possible from each judge. 100 total possible points.

- 1) Questions from the judges 0 to 40 points
- 2) Streetwear/Speech 0 to 20 points
- 3) Physique/Question 0 to 20 points
- 4) Full Leather Image 0 to 20 points

Contestants will appear before the judges at least four times.

- 1) Questions by the judges, interview, will be based on the knowledge of community, national, international, HIV/AIDS, events, leather awareness, personality and attitude etc.
- 2) Streetwear competition will be judged on the dress as you would wear shopping, work, to the movies etc.
- 3) Physique..... you will be judged on physical appearance in swimwear or jockstrap which MUST conform to Oklahoma's nudity laws. ( AT LEAST A 2" VISIBLE STRAP DOWN THE BACKSIDE! ).
- 4) Full Leather Image, you will be judged on your outfit conveying "YOUR" full leather appearance.
